General Note:

• The Hostel fee shall be charged for the whole academic year. In case a candidate is allotted in the middle of academic year, the hostel charges shall be calculated at quarterly basis. Full Hostel charges shall be payable for full quarter or part thereof.

First Quarter: 1st July to 30th September; Second Quarter: 1st October to 31st December Third Quarter: 1st January to 31st March 1st April to 30th June

- A hostler will have to deposit an amount of **Rs. 10,000/-** as Hostel Security Money. The Security money will not be refunded if a student over stays in the hostel for more than a month after the last examination held for a particular course.
- AC charges would be extra of Rs.25000/- a year per student in sharing rooms.
- The above Annual Hostel Fees would be applicable for academic Session 2016-17. Allotment of Hostel for subsequent years shall be afresh and at rates as prevalent in those years.
- Hostellers will have to vacate the hostel at the end of the academic session (after annual/semester examinations). Seats in the hostel would be allotted afresh to the students in the month of July when the new academic session begins.
- Mechanical Laundry Facility is available and is mandatory for hostellers in the University. An allottee will have to deposit the annual Laundry charge for washing of clothes as per rules of the University along with Annual Hostel Fee. The charges will be decided by the University every year.

- Availing the Mess facility will be compulsory for the Hostellers of Jamia Hamdard Hostels. The mess charges will be as prevalent every year.
- Hostel bylaws will be applicable to the hostlers

Important note, MBBS:

- The fee for supplementary examinations will be charged separately as per rules of the University.
- The Annual course fee for Second year MBBS and onwards are required to be deposited by the 31st day of July of every years of the academic session, and in case of failure to deposit the course fee in time as prescribed shall be liable to pay fine of Rs 200/- per day up to 30 days and 2% per month or part thereof for another month and thereafter the University may take action accordingly.
- Full annual fee will be charged for MBBS Course for the final year which is taught for six months in the last year of the course.
- All the fees will be paid through Bank Demand Draft in favor of **HIMSR** payable at New Delhi.
- No fee concession is available for the students of MBBS Course, however the University offers few Scholarships to eligible students and students can apply and avail the same as per the University norms.

ANNUAL HOSTEL FEE FOR MBBS STUDENTS

University has following two hostels for MBBS students:

• *Ibn-e-Batuta* (Boys Hostel)

• Abdul Mueed Hall of Residency (AMHR Girls Hostel)

The Annual Hostel Fee for MBBS students for A.M. Halls of Residency (Girls Hostel) and Ibne-Batuta (Boys Hostel) will be as given in Annual Hostel Fee 201617.

The Hostel inmates will be required to comply with the rules and regulations as per 'Jamia Hamdard Hostel bylaws'.

GUIDELINES FOR WITHDRAWAL OF ADMISSION AND REFUND OF FEE FOR ACADEMIC YEAR 2016-17

Following rules will govern the refund of fee in case of withdrawal of admission.

- (i) Admission fee and Enrolment fee will not be refunded in seeking the withdrawal of admission.
- (ii) In case a student / candidate seeks withdrawal of the admission on or before the closure of admission as notified in the General Information and Prospectus (Important Dates) or on Jamia Hamdard website, the entire fee collected from the student / candidate at the time of admission / provisional admission shall be refunded after deduction of processing fee Rs. 1,000/-.
- (iii) In case a student / candidate withdraws his/her admission within one month after the closure of admission as notified in the General Information & Prospectus (Important Dates for Programs) or on Jamia Hamdard website, 80% of the 1st semester fee deposited by the candidate, may be refunded along with full fee of other semesters, if fee is deposited by the candidate for more than one semester or for entire course, after deducting fee concession availed by the candidate, if any.
- (iv) In case a student / candidate withdraws his/ her admission within two months after the closure of admission as notified in the General Information and Prospectus (Important Dates for Programs) or on Jamia Hamdard website, 60% of the 1 semester fee deposited by the candidate, may be refunded along with full fee of other semesters, if fee is deposited by the candidate for more than one semester or for entire course, after deducting fee concession availed by the candidate, if any.
- (v) In case a student / candidate withdraws admission after two months of the closure of admission as notified in the Information Bulletin & Prospectus (Important Dates for Programs) or on Jamia Hamdard website, whether he/she attended or not attended classes, his/ her admission will be cancelled and in such case full first semester fee shall be not be refunded. However, rest of semesters' fee, if deposited by the candidate, shall be refunded after deducting fee concession availed by the candidate, if any.
- (vi) In case a candidate/student is admitted after the date of closure of admission as notified in the Information Bulletin and Prospectus (Important Dates for Programs) or on Jamia Hamdard website and withdraws his/her admission thereafter, fee may be refunded as per above rules applicable for withdrawal of admission after closure of admission as notified at Sl. No. 4.

Note: It should be noted that date of closure of admission will remain same as notified in the Information Bulletin and Prospectus (Important Dates) or on Jamia Hamdard website, whether admissions are made before or after that date.

GUIDELINES FOR WITHDRAWAL OF ADMISSION AND REFUND OF FEE FOR MBBS PROGRAMME FOR ACADEMIC YEAR 2016-17

Following rules will govern the refund of fee in case of withdrawal of admission.

- 1. Admission fee and Enrolment fee will not be refunded in seeking the withdrawal of admission.
 - 2. In case a student / candidate withdraws his/her admission before commencement of the classes as notified in the Prospectus 2016-17 (Important Dates for MBBS Programme) or on Jamia Hamdard website, the entire fee collected from the student / candidate at the time of admission / provisional admission shall be refunded after deduction of the processing fee which is **Rs. 1000/-.**
- 3. In case a student / candidate withdraws his/her admission on or after commencement of classes and before closure of admission as notified in the Prospectus 2016-17 (Important Dates for MBBS Programme) or on Jamia Hamdard website, the fee collected from the student / candidate at the time of admission / provisional admission shall be refunded after deduction @ Rs. 1,700/- per day for General/Reserved category candidates and Rs. 4,200/- per day for management quota category from the commencement of classes till the date of withdrawal of admission.
- 4. In case a student / candidate withdraws his/her admission on or after closure of admission as notified in the General Information & Prospectus 2016-17 (Important Dates for MBBS Programme) or on Jamia Hamdard website, annual fee of the admission year deposited by the candidate/student will not be refunded.

Note: Closure of admission will be as per announcement of the University at its website.
